The J.B. Brown Scholarship Fund is intended to provide educational grants to residents of USA Properties affordable housing communities to support their goals of furthering their education and building community. We are delighted that you are considering applying and encourage you to read the application thoughtfully. Please follow directions carefully to ensure you submit your best application possible. For those applicants that reside at a USA property where LifeSTEPS services are available please contact your Director of Social Services for assistance.

Please read through the criteria to determine if you are a good fit for this opportunity. Pay special attention to the submission process and list of attachments to ensure you are submitting a complete application. Incomplete applications will not be considered. If you have any questions, please reach out to LifeSTEPS staff, your on-site DSS or by emailing scholarships@lifestepsusa.org.

You are encouraged to submit your application for review in advance of the deadline to verify that it is complete.

Eligibility Criteria – Applicants are required to meet ALL criteria to be considered for funding.

- Applicant has lived in a USA Properties community for two or more years, has had no more than three
 late rent payments during the past 12 months, and is considered to be in good standing by USA Properties
 (Exceptions: If community is less than two years old, a minimum of six months required or residency at
 multiple properties totaling 2 years is acceptable.)
- Applicant is a graduating high school senior, GED recipient or undergraduate enrolling in an accredited undergraduate program. Note: Graduate programs not eligible.
- Applicant can demonstrate community leadership through volunteer work at school or in the community.
- Applicant can provide proof of acceptance to an accredited University or Community College for full or part-time programs. Applicant is registered for a minimum of 6 units.
- Applicant's GPA from most recently completed term is 2.5 or higher. Student GPAs and academic progress will be monitored.
- USA Properties and LifeSTEPS employees and their family members and household members are not eligible for funding.
- Applicant must be able to demonstrate at least one source of income to pay for schooling.

I understand that if I withdraw from or achieve less than a 2.5 GPA while receiving scholarship funds, LifeSTEPS has the authority to adjust or cancel the award accordingly.

 - (a) change my college
 - (b) change my permanent address
 - (c) cease to carry the minimum of 6 academic units
 - (d) achieve less than a 2.5 GPA while using J.B. Brown Scholarship Fund funds
 - (e) stop attending an institution of higher education
- 3. I understand that LifeSTEPS has the right to request transcripts to verify my GPA and my academic progress.
- 4. I understand that I need to reapply for this scholarship annually. There are two scholarship opportunities each year.
