The J.B. Brown Scholarship Fund is intended to provide educational grants to residents of USA Properties' affordable housing communities to support their goals of furthering their education and building community. We are delighted that you are considering applying and encourage you to read the application thoughtfully. Please follow directions carefully to ensure you submit your best application possible. For those applicants that reside at a USA property where LifeSTEPS services are available please contact your Director of Social Services for assistance. Please read through the criteria to determine if you are a good fit for this opportunity. Pay special attention to the submission process and attachment list to ensure you submit a complete application. Incomplete applications will not be considered.

You are encouraged to submit your application for review in advance of the deadline to verify that it is complete.

Eligibility Criteria – Applicants are required to meet ALL criteria to be considered for funding.

- Applicant has lived in a USA Properties community for two or more years, has had no more than three
 late rent payments during the past 12 months, and is considered to be in good standing by USA Properties
 (Exceptions: If the community is less than two years old, a minimum of six months required or residency
 at multiple properties totaling 2 years is acceptable.)
- Applicant is a graduating high school senior, GED recipient, or undergraduate enrolling in an accredited undergraduate program. Note: Graduate programs are not eligible.
- Applicant can demonstrate community leadership through volunteer work at school or in the community.
- Applicant can provide proof of acceptance to an accredited University or Community College for full or part-time programs. The applicant is registered for a minimum of 6 units.
- Applicant's GPA from the most recently completed term is 2.5 or higher. Student GPAs and academic progress will be monitored.
- USA Properties and LifeSTEPS employees and their family members and household members are not eligible for funding.
- Applicant must be able to demonstrate at least one source of income to pay for schooling.
